## for articles made from plastic intended to come into contact with food

Hereby we confirm that our product:

## MOUNTAIN Bev Bottle cha. black mat 0,90l Item No.: 4015.232.090

complies with the legal regulations laid down in the German Commodity Ordinance (or the respective stipulations laid down in the European Regulations on Plastic materials) as well as Regulation (EU) No 10/2011, the Regulation (EC) No. 1935/2004 and the Regulation (EC) No. 2023/2006, in their relevant versions.

Description (material/optics): body made of double walled stainless steel, black lacquercoated; 2-part lid - inner stopper of grey plastic (PP – Polypropylene) with translucent gasket – outer stopper of black plastic (PP – Polypropylene) with translucent gasket. Drinking rim of black plastic (PP – Polypropylene) with translucent gasket; Drinking cup of grey and black plastic (PP – Polypropylene); gripping area of green plastic (PP – Polypropylene); Bottom cap of black silicon.

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. Testing is done in accordance to regulation 82/711/EWG and 85/572/EWG in compliance to Art. 17 and 18 of the Regulation (EU) No. 10/2011 in conjunction with annex V and with Regulation (EU) No. 2016/1416.

The materials and raw materials used, comply with the German Commodity Ordinance (or the respective stipulations laid down in the European Regulation (EC) No1935/2004 and the Regulation (EU) No 10/2011.

- Ratio of the area of the food contact surface to the nominal filling volume used to determine the compliance of the food contact material or article:

6,27 dm²/kg

Material recipes do not contain Dual-use-additives.

There is no functional barrier used in the plastic material.

Due to the risk of increased bacterial growth, this product is not suitable for keeping dairy products or baby food warm.

The product cannot be used for heating on stoves, in conventional or microwave ovens.
