Description (materials/optics): body and lid made of single wall stainless steel, surface inside high-mirror polished, outside matt finished and lacquer coated blue, retaining strap made of gray silicone.

The total migration as well as the specific migrations are below the legal limits when used according to specification. The tests are carried out in accordance with Regulation (EU) No. 10/2011 in conjunction with Annex V and Regulation (EU) 2016/1416.

The materials and raw materials used comply with the Consumer Goods Ordinance, Regulation (EC) No.1935/2004 and the EU Food Plastics Regulation (Regulation (EU) No. 10/2011).
